The Journal publishes articles on all aspects of law, religion, and policy in Italy and abroad. It is published four times a year and each issue has a specific focus. SUBMISSIONS

The journal welcomes papers addressing any topics of interest to the journal, to be published in the miscellaneous section of issue no. 2. Authors are kindly requested to follow the editorial guidelines below and to submit their paper in .doc format to redazione.qdpe2@gmail.com no later than 30 March 2018. Contributions are welcome in Italian, English and Spanish. The papers will be peer-reviewed and authors will be notified of the reviewer's recommendation (accepted / accepted subject to change / rejected). Issue no. 2 will be published in October 2018 in both print and online version.

EDITORIAL GUIDELINES

A maximum 36,000 keystrokes, including spaces and notes, are allowed.

Papers should be accompanied by an abstract in English language (maximum 500 keystrokes, spaces included), along with 3 to 5 keywords.

Papers must be organised in paragraphs:

- 1. (Title of paragraph)
- 1.1. (Title of subparagraph)
- 1.2. (...)
- 2. (...), etc.

In the text (Roman types) use *Italics* for:

- terms and phrases written in foreign languages (e.g., if the contribution is written in English, *foulard*, *Weltanschauung*, *villa*, *continuum*, *shariah*);
- phrases aimed at being emphasised. Use italics sparingly;
- idem, ibidem, et al., A/N, ex, bis ter quater..., etc. (etc. included).

Please do not use in the text or in the titles UPPER-CASE, SMALL CAPITAL, **bold**, <u>underlined</u> types, nor any mix of them, as well as forms of overzealous punctuation.

Footnotes should be brief and informative, and numbered consecutively in Arabic numerals. Footnotes must not be attached to the title of the article, the summary or any headings.

As regards notes and bibliography system, comply with the *Chicago Manual of Style*. In-text references should only mention the author's surname, the publication year and, if necessary the page(s), e.g. Waugh (1938), or (Waugh 1938), or (Waugh 1938, 85-92). If there are two or more publications of the same author published in the same year, a letter should be included, e.g. (Waugh, 1938 b). At the end of the paper, bibliographical references should be listed according to the author's surname and, for each author, according to the publication year, e.g.:
